PARTICIPATION RELEASE AND WAIVER

As a condition of my participation in the 2019 Lumberjacks Youth Wrestling Camp (the Event) as a camp participant, volunteer or otherwise, I hereby covenant not to sue and agree to release from liability the Lumberjacks Youth Wrestling Camp, together with its founders, officers, coaches, directors, managers, coaches, camp staff, volunteers and the Cloquet School District and any and all other sponsors, suppliers, agents, independent contractors, and other personnel in any way assisting or associated with this Event (collectively "Releases"). This release is a contract with legal and binding consequences and it applies to all activities relating to the Event. I have read this document carefully before signing, and I understand what it means and what I am agreeing to by signing.

In consideration of the acceptance of my application for entry or participation as a wrestling camp participant or volunteer in this Event by one of more Releases', I hereby freely agree to and make the following contractual representations and agreements.

I understand that this Event involves full contact wrestling, takes place in a small gym on a single competition size wrestling mat with a number of other wrestling participants at the same time making participation in this event a potentially hazardous activity. I voluntarily assume full and complete responsibility for all risks associated with this Event, including by way of example and not limited to: skin infection, collisions, bone injury, joint injury, spinal injury, concussion, skin injury, bruising, the; the negligence of myself and/or others. I am aware of and appreciate all of these risks.

I acknowledge that I should not enter and participate in this event unless I am medically able and properly trained. I agree to abide by any decision of the Camp Director to my ability to safely participate in this event and I further agree that the camp director and his assistants may authorize necessary emergency treatment for me.

Having read this waiver and knowing and assuming these risks, and in consideration of the acceptance of my participation, I hereby for myself, my heirs, my executors, administrators and anyone else who might claim on my behalf (collectively "Successors"), covenant not to sue, and waive, release and discharge Releases' from any and all claims or liability of any kind or nature whatsoever arising out of my participation in this Event, even though such liability may arise out of negligence or carelessness on the part of Releases. I hereby authorize Lumberjacks Youth Wrestling Camp to use my image or likeness for camp promotional purposes.

I acknowledge and agree, for myself and my Successors, that the above representations are contractually binding, and are not mere recitals, and that should I or my Successors assert a claim contrary to what I have agreed to in this agreement, the claiming party shall be liable for the expenses (including legal fees) incurred by the Releases' in defending such claim. This agreement may not be modified orally, and a waiver or modification of and provision shall not be construed as a waiver or modification or any other provision herein or as consent to any subsequent waiver or modification. I consent to the release by any third party to Releases' and their insurance carriers of my name and medical information that may relate to any injury or death I may suffer arising from my participation in the Event. Every term and provision of this agreement is intended to be severable. If any one or more of them is found to be unenforceable or invalid, that shall not affect the other terms of and provisions, which shall remain binding and enforceable.
